The program is structured into a one-year general program mainly offered in Rome, and a second year in other locations, focusing on alternative areas of specialisation: Children, Adults, Elderly, each referring to both the general population as well as to special groups, and dealing with such issues as:

- Health and fitness, risk factors and prevention in the general population
- Movement therapy in functional re-education & rehabilitation
- Wellness and coping in disability, chronic disorder, or other limiting conditions
- Maturation and social integration, wellness and creativity, personal growth and expression

Admission:

The program is addressed to students with an undergraduate degree in the sport science or related area, with good knowledge of written and spoken English and adequate credentials. A total of 38 students will be admitted, with possible extensions in case of qualified applications. 16 positions are reserved to students from partner universities. 7 additional positions are restricted to non-European students. Wide international participation is encouraged.







Fees & Support:

All international students are entitled to the same student assistance services as Italian students, on the basis of the same requisites of financial means and/or merit. This applies to scholarships, student loans, housing assistance, and fee waivers.

The tuition fees amount is payable in two instalments:

- First instalment fee: € 481,13 (enrolment national tax, insurance), to be paid when you enrol;
- Second instalment fee: from € 0,0 to € 1.662,52 depending on the family income.

First two higher candidates in the ranking lists from each consortium university will be exempted from payment of university fees but IT Services and Regional Tax DSU and virtual duty stamp (total € 156,00) provided they comply each year with specific merit requirements. Additional students from consortium universities, with the exception of Italian students, are allowed to pay taxes and contributions of the two-year course in a single fixed settlement of € 3,200.00.

Single Modules:

Candidates meeting admission requirements can be admitted to single modules on payment of € 800,00.

Applications:

Students from the Universities of Cologne, Odense, Oslo, Vienna will be selected by their respective local coordinators, subject to the number of positions available.

Students from University of Rome "Foro Italico" and all other students should submit their application and documents to the head office in Rome.

The deadline for the application is 19 July 2021 at 13:00 (Central European Summer Time). Applicants will be immediately notified about selection procedures, which will be completed by 28 July 2020.

The program starts on Monday 11 October 2021*.





Main figures and quality assurance indicators 2019-2020 plus 3-year trend


Students attending the EMH&PA program 2010-2020

Contribution of European partner universities to the 2nd year teaching activities (ECTS)





REGULARITY OF STUDENT CAREERS

(Indicators from MIUR-SMA annual monitoring – update January 2021)

Regular students show a good percentage of ECTS acquired at the end of the 1st year, with a slight decrease in the a.y. 2017/2018, still higher when compared to the situation at national level for the same II level programs (1); Not less than 97% of students progress towards the 2nd year of the study program, with an excellent percentage of graduates within the program duration, although a decline is seen in 2019 (2).

Gli indicatori della didattica mostrano un buon andamento delle carriere degli studenti, stabile nel tempo, con una leggera diminuzione nella % di CFU acquisiti al termine del I anno, comunque decisamente superiore alla situazione nazionale (1), con il 100% di studenti che prosegue al II anno e una percentuale molto elevata di studenti che si laurea entro la durata regolare del corso, sebbene in calo nel 2019 (2).






REGULARITY OF STUDENT CAREERS



The percentage of regular students acquiring 2/3 of mandatory ECTS within the I year is satisfactory and stable in the 3-year trend (3), while the percentage of students that withdraw from the program shows an increase in the 3-year trend, reaching the national value in the 2018 (4).

La percentuale di studenti che acquisiscono non meno di 40 CFU entro il primo anno di corso è soddisfacente con un andamento stabile nel triennio, mentre in aumento la percentuale di abbandoni, passata, nel triennio, dallo 0% del 2016 al 7,4% del 2018, sovrapponendosi al valore a livello nazionale.



% of withdrawing students within 2+1 years





ATTRACTIVENESS AND INTERNATIONALIZATION OF THE STUDY PROGRAM

(Indicators from MIUR-SMA annual monitoring – update January 2021)

The uniqueness of the LM67-I study program at national and international level is verified by its attractiveness among bachelor graduates from universities other than Foro Italico (5), with a very distinct percentage of enrolled students (about 40%) that acquired their bachelor degree abroad (6).




ATTRACTIVENESS AND INTERNATIONALIZATION OF THE STUDY PROGRAM

(Indicators from MIUR-SMA annual monitoring – update January 2021)

The % of ECTS acquired abroad is very high, in line with the structure of the joint program, and usually higher than the mandatory amount (12,5%), reflecting the students' interest towards international training experiences (7). The tendency to decline in the last two years could reflect the incapability of the students to attend elective activities abroad.

L'eccellenza del grado di internazionalizzazione è verificata anche dal numero medio di CFU acquisito all'estero da ogni studente, superiore del minimo obbligatorio del 12,5% (7). Il declino che si nota nell'ultimo periodo potrebbe essere dovuto all'impossibilità degli studenti di frequentare attività a scelta offerte dalle università partner.







PROGRAM SATISFACTION BY GRADUATING/GRADUATES

(Indicators from MIUR-SMA annual monitoring- update January 2021)

The program satisfaction by graduating students (8) and graduates (9) shows a positive 3-year trend, comparable to the Italian national situation (8), with an excellent satisfaction towards the relationship with the teachers (92%) and with other students (100%).




EMPLOYABILITY OF GRADUATES

Despite the apparent negative trend in 2017, the employability of graduates after 3 year from the program completion is good, comparable to the situation at national level (10).




Students' evaluation of the 2019-2020 Teaching Activities expressed as % of Positive Evaluation Index (IVP)

The evaluation of **2019-2020** teaching activities by the students shows very positive indeces (between 80% and 99%), higher than the critical threshold of 70% set by the University of Rome Foro Italico (11), with some bias for the 2° year course, showing a low participation by the students.

IVP total


Students' evaluation of the 2019-2020 Teaching Activities expressed as % of Positive Evaluation Index (IVP)

The 2019-2020 overall evaluation of the organization, content and teaching modality of the program is positive, with IVPs ranging between 84% and 95% (12).

In generale, la valutazione 2019-2020 da parte degli studenti riguardo l'organizzazione, contenuti e qualità della didattica del programma è positiva con indici IVP compresi tra l'84% e il 95% (12).

Considering the 3-year trend (13), the overall evaluation of different courses shows a general positive trend, with stable or increasing values, with the resolution of past critical situations.

Rispetto al triennio 2017/2018 – 2019/2020 (13), la valutazione della didattica da parte degli studenti mostra una valutazione generalmente positiva per tutti i corsi, con valori stabili o in miglioramento e la risoluzione di alcune criticità presenti negli anni precedenti.
